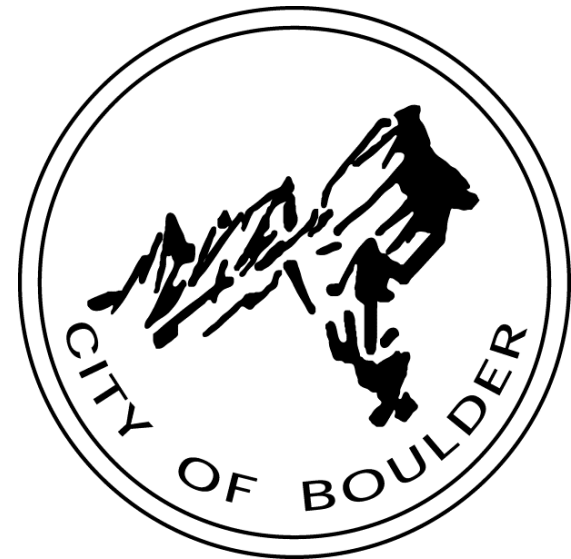

**FEE:** \$63.00 / month      October – April  
\$125.00 / month      May – September

**“Ambulatory Vendor” means a portrait, caricature or landscape artist, or any person who engages in the business of selling balloons, balloon sculptures, flowers or shoe shines.**

### Licenses required for permit approval:

### Only these items in a five foot by six foot area:

- One easel
- Two chairs
- One free standing signs that does not exceed the size of 18 inches by 18 inches
- One small stool

### No Ambulatory Vendor shall place:

Any cart, unrolled blanket, tent, booth, canopy, stage, table, movable structure or other similar equipment on the mall.
