The goal of the grant is to increase the exposure of students to unique and memorable experiences that may shape their future in cultural participation and creative careers.

Total Funds: \$30,000

#### **ELIGIBILITY REQUIREMENTS**

• General eligibility. Meets all general eligibility requirements.

- Open to educators, administrators, and presenters. Classroom teachers and school administrators in public schools, private schools, home school associations, and non-traditional classroom settings, as well as artists / individuals / organizations collaborating with schools on programming are eligible.
- Service area and programming. Projects must have a significant component of public programming that takes place within the city limits of Boulder. This programming must meet the criteria described in the Chapter 14-1-2 of the City of Boulder Revised Code. For organizations, the applicant must demonstrate that they are headquartered in the city limits of Boulder. For individuals, the applicant must demonstrate that they reside at a permanent household address in the city limits of Boulder. Applicants may also demonstrate that they are partnered with a Boulder-based artist or organization. Examples of documentation to demonstrate being headquartered or residing in Boulder may include a utility bill, phone bill, pay stub, renter's or mortgage bill, lease, insurance policy, or other official document. P.O. Boxes are not acceptable. The term "city limits of Boulder" is defined in the Boulder Valley Comprehensive Plan. For additional information on the planning area and Comprehensive Plan visit this link. As a shorthand, office staff use addresses with the zip code starting with 803— to determine if it is in the acceptable area.
- Timing. Projects must take place after the grant deadline and end before the end of the 2024 spring semester.

#### **REVIEW PROCESS**

- Deliberation. Applications are reviewed by the Boulder Arts Commission grants panel. Final funding decisions are made at public Boulder Arts Commission meetings. See schedule.
- Evaluation of applications. Funding in previous years does not imply continued support. Each application is reviewed anew in the context of current policies and applications. Applicants that have received repeated funding should be aware that the Boulder Arts Commission looks for indication of growth and a fresh approach to their work.
- Evaluation criteria
  - o Benefit to students (Maximum 8 points)
  - o Complementing curriculum (Maximum 8 points)
  - o Proposed outcomes and evaluation strategy (Maximum 8 points)
  - o Community Priorities (Maximum 8 points)

  - o Encouragement points (Maximum 4 points)

#### **APPEALS PROCESS**

Written appeals process. The deadline for a written appeal is 14 days after funding decisions has been made by the Boulder Arts Commission. The appeals process can be found on our website.

#### **GRANT AWARDS**

Notifications and dispersal of funds. Staff notifies all applicants if their Application has been successful
and begins the process of securing supporting information and issuing payment for successful
applicants. Grantees must contact the grant coordinator to arrange for payment. Checks are sent by mail
or electronically to bank accounts designated by the applicant.

- Communications. All official communications and notifications will be made to the named individual applicant or person designated as the organization contact. It is this person's responsibility to communicate Boulder Arts Commission requirements of the grant award to collaborators or other participants. This includes, but is not limited to, requirements for compliance with grant agreements, identifying Boulder Arts Commission sponsorship on publicity materials, and reporting.
- Implementation. Grantees shall implement programs / projects as outlined in the grant application. Any change to the project, venue, Grantee address, schedule, or staff / team members must be reported to culturegrants@bouldercolorado.gov.
- **Award amount.** The Boulder Arts Commission reserves the right to adjust the amount of a grant award offered to an Applicant.
- **PERA impacts**. Retirees affiliated with the Colorado Public Employees Retirement Association (PERA) will be impacted by a withholding requirement enacted by the Colorado State Legislature if awarded an arts grant. Details are available on the PERA website. See "Disclosure of Compensation."
- Vendor Forms. Grantees must submit a City of Boulder vendor form and current IRS W-9 form in order to
  receive the grant award. The W-9 must be in the same name as the Grantee named on the grant
  application. Individual Grantees must also submit a Determination of Independent Contractor / Employee
  Status for Payment document and copy of their Driver's License. Applicants will receive the appropriate
  forms from payments@bouldercolorado.gov. Failure to supply a proper W-9 may invalidate the grant
  award.
- IRS taxation. Grant awards are non-transferable, taxable and are reported to the federal government.
- Agreement. When a grant award is made by the Boulder Arts Commission, the successful Applicant will be contacted by staff to sign a Gant Letter of Agreement. In that agreement, the Grantee will indicate the completion date of the project and the date a grant report will be submitted.
- Issuance of funding checks. Once the agreement is signed, staff of the Office of Arts and Culture will submit it to City Finance along with the invoice. Funds/checks are delivered within the next three weeks. Grants are initially funded at 80 percent of the grant amount awarded. The remaining 20 percent of the grant awarded is paid out upon receipt and Boulder Arts Commission approval of the grant report. Failure to submit a final grant report will result in ineligibility to apply for future grants.
- Acknowledgment of Boulder Arts Commission funding. All publicity for Boulder Arts Commission-funded projects must include the following credit line: *This project is funded (or funded in part) by a grant from the Boulder Arts Commission, an agency of the Boulder City Council.* In lieu of the credit line, the Boulder Arts Commission Logo may be used. The Grantee must sign a release form and submit photographs and/or videos of the project that the Office and Arts and Culture may use on its website, social media, printed materials or for any other publicity purpose.
- Thanking City Council. It is suggested that all grant recipients write the Boulder City Council members to
  thank them for supporting the Boulder Arts Commission and the Office of Arts and Culture. Please let
  them know how this grant will be used, and the difference it will make to your organization. Please also

#### REQUIRED REPORTING

   Commission in advance of the due date, all individuals or organizations / businesses attached as
   collaborators on the project will no longer be eligible to apply for Boulder Arts Commission grants until
   the delinquent report has been received.

## Project summary\*

Our free outreach programs for youth provide films, panels, a competition, and workshops to ignite a lasting sense of intercultural, artistic, and technical imagination in the next generation. Topics have included racism, art, science, social justice, history, and STEM. Students speak with the artists or subjects behind the films, providing an inspiring and important learning experience. Our program includes films that complement curriculum and reach underrepresented students in the schools. We reached 596 students in 2023 and plan for 650 students in 2024.

We offered 4 films free for students at BIFF 2023 including Afghan Dreamers, Case for Kindness, RIDE, and My Sister Liv. We also offered a workshop with the Boulder Film Commission called How to Be a P.A. attended by 30 students. The 2023 Cinema to Schools for 200 students at BHS was Afghan Dreamers, a powerful film about an all-girls robotics team in Afghanistan who risks it all while working in secret under Taliban rule. Five BHS students moderated a discussion after the film with the filmmakers.

The Teen Short Film Competition during BIFF had 160 attendees at the Century and featured a performance by teen musicians. There were 120 films submitted and 6 student awards.

#### Benefit to students\*

In what ways will this project directly benefit the students and their growth as cultural participants or in the creative industries? What new skills or experiences will be offered?

We use film as a way to open students' eyes to the diverse world outside their communities, as a way for students to develop analytical skills, to promote creativity/filmmaking skills, and as an important avenue of expression. Our program 1) promotes a youth voice using the art of film as a form of communication, through film instruction, and interaction; and 2) builds understanding of others' lives, ethnicities, and human experiences by helping students to learn about other cultures and important issues.

An example of a free student film at BIFF 2023 was My Sister Liv, about a young Boulder woman's suicide and her family who tried to save her. The discussion (moderated by a teen) featured The Liv Project, who collaborate with youth and mental health professionals to create tools aimed at sparking fearless communication that can save lives. We gave 115 tickets to young people for the screening.

We offered the 'How to Be a Production Assistant' workshop in 2023,-which was free for those unable to pay. We also hold a teen competition and were excited to learn that a teen filmmaker was accepted into a short film fest after BIFF and a teen musician who performed has gotten local gigs due to a contact she met at BIFF.

## Complementing curriculum and offerings\*

Our Educational Outreach Program complements and sometimes fills the gap in curriculum and offerings.

Our programs enhance school curriculum with films, panels and discussions on topics like language, history, social studies, and STEM. For example, a documentary at Cinema to Schools related to STEM was the 2023 film Afghan Dreamers, about an all-girls robotics team in Afghanistan who risks it all while working in secret under Taliban rule.

We also help fill the gap in curriculum. One film offered free for youth at BIFF 2023 was RIDE, an inspiring story about the lives of BMX champions Sam and Alise Willoughby, who fall in love, only to have their lives turned upside down by an accident that leaves Sam a tetrapalegic. The film is a bold picture of the trauma involved in facing the unthinkable, and is ultimately a lesson in reinvention and hope. Sam and Alise took part in a powerful and inspiring Q & A afterwards. Many filmmakers and historical leaders have spoken at our student screenings including Presidential Medal of Freedom honoree Rep. John Lewis and Apollo astronaut Gene Cernan.

Through these programs, we supplement the educational experience and address issues through a broader and often more immediate perspective.

## Proposed outcomes and evaluation strategy\*

We believe that evaluation is an invaluable tool for organizational and programmatic assessment. The CFS evaluates this program in several ways: (1) quantitatively through increases in teens attending the free screenings at BIFF, at Cinema to Schools, participation in the filmmaking contest and workshops and; (2) qualitatively through teen feedback through email and our website and through feedback from students, teachers, panelists, filmmakers and school administrators. (See letter of support from Boulder High School Vice Principal). Feedback from the students is further collected on an informal basis in discussions following speakers and events.

Change is implemented collaboratively by the Educational Outreach Coordinator, staff, Board of Directors/Advisory Board who measure impact and map accomplishments, identify strengths and areas of improvement and identify, review, evaluate, and recommend clear long and short term changes and goals.

The City of Boulder's Community Cultural Plan is a visioning and strategic document that describes how the people of Boulder will align efforts, with the support of the municipal government, to achieve our collective vision: Together, we will craft Boulder's social, physical, and cultural environment to include creativity as an essential ingredient for the wellbeing, prosperity, and joy of everyone in the community. Supportive Environment: Our outreach program promotes positive youth development by building interpersonal, leadership and creative skills. Our free outreach programs give students a chance to speak with and learn from filmmakers, subjects and other artists. We hold workshops for students on topics that have included how to develop a story, be a Production Assistant. or how make a short film. BIFF provides exhibition opportunities for young filmmakers through our Teen Short Film Competition and young musicians perform before the competition. The scoring rubric for youth judges is shared with all entrants and includes evaluation of writing, sound design, cinematography, editing and directing.

Civic Dialogue on important topics is the core of our mission. Filmmakers/subjects talk with students after screenings, giving our youth the rare opportunity to have a dialogue with the artists and subjects behind the films. We also promote a youth voice by using the art of film as a form of communication, and through film instruction and interaction. We have worked with teachers in the BVSD to develop study guides to promote dialogue on an important and timely topics.

Creative Identity: BIFF has a reputation as one of the most innovative festivals in the US and receives extensive media coverage nationally, helping to establish Boulder as a leader in arts and cultural programming. Our educational outreach programs help students become literate film viewers, as well as innovative and artistic human beings. Our youth filmmaking competition provides a rare offline opportunity for our young people to be recognized and have their work presented in a major film festival, creating opportunities for collaboration, recognition, and innovation.

We are the only group of its kind in Boulderand all youth programs are free, removing financial barriers for students/schools. We reached 596 students in 2023.

Films have included topics on diverse issues such as, race, disability, and social justice. We brought Cinema to Schools to BHS in 2023 which has a 30% minority/Hispanic population and a 22% of students who qualify for free lunch. We strive to work with diverse students in Boulder, which has included helping a Latina club make a film and helping Pathways2Teaching make a film to recruit underserved students. Our free programs at BIFF provide us with opportunities to promote inclusiveness and creativity. The teen competition is accessible to all youth and there is no fee to enter. We communicate to students that the competition seeks inclusive storytelling from all perspectives regardless of ethnicity, gender, disability, social class etc. Several of the winners in 2023 were diverse students.

Our program addresses affordability, accessibility, availability, acceptability and accommodation in the unique and transformative ways above and provide us with unlimited opportunities to inspire and educate our youth.
