- Develop Boulder's creative identity in becoming an innovative world leader in cultural matters and projects that identity to the region and the world.
- Focus on the expression of culture and creativity in the public realm through public art, the urban landscape, culture in the neighborhoods, and serendipitous encounters with the arts.
- Amplify the vibrancy of Boulder's cultural destinations: the lively mix of museums, performance venues, events, districts, studios, maker spaces, and other facilities that make Boulder an enticing place to visit, live, play, and work. These complex issues are the most important initiatives we can work on as a cultural community in the coming years. The purpose of the Community Projects Grant is to encourage innovation and exploration in order to achieve progress on these Community Priorities.

- **Open to all.** Anyone may apply once the <u>general eligibility requirements</u> are met, including individuals, artists, non-profit organizations, organizations with pending non-profit status, fiscally sponsored organizations and for-profit organizations with a community focus.
- Service area and programming. Projects must have a significant component of public programming that takes place within the city limits of Boulder. This programming must meet the criteria described in the <u>Chapter 14-1-2 of the City of Boulder Revised Code</u>. For organizations, the applicant must demonstrate that they are headquartered in the city limits of Boulder. For individuals, the applicant must demonstrate that they reside at a permanent household address in the city limits of Boulder. Applicants may also demonstrate that they are partnered with a Boulder-based artist or organization. Examples of documentation to demonstrate being headquartered or residing in Boulder may include a utility bill, phone bill, pay stub, renter's or mortgage bill, lease, insurance policy, or other official document. P.O. Boxes are not acceptable. The term "city limits of Boulder" is defined in the Boulder Valley Comprehensive Plan. As a shorthand, office staff use addresses with the zip code starting with 803— to determine if it is in the acceptable area.
- Projects must take place after the grant funding decision and be completed by June 30, 2024.

REVIEW PROCESS

GRANT AWARDS

- Notifications and dispersal of funds. Staff notifies all applicants if their Application has been successful and begins the process of securing supporting information and issuing payment for successful applicants. Grantees must contact the grant coordinator to arrange for payment. Checks are sent by mail or electronically to bank accounts designated by the applicant.
- **Communications**. All official communications and notifications will be made to the named individual applicant or person designated as the organization contact. It is this person's responsibility to communicate Boulder Arts Commission requirements of the grant award to collaborators or other participants. This includes, but is not limited to, requirements for compliance with grant agreements, identifying Boulder Arts Commission sponsorship on publicity materials, and reporting.
- Implementation. Grantees shall implement programs / projects as outlined in the grant application. Any change to the project, venue, Grantee address, schedule, or staff / team members must be reported to culturegrants@bouldercolorado.gov.
- Award amount. The Boulder Arts Commission reserves the right to adjust the amount of a grant award offered to an Applicant.
- **PERA impacts**. Retirees affiliated with the Colorado Public Employees Retirement Association (PERA) will be impacted by a withholding requirement enacted by the Colorado State Legislature if awarded an arts grant. Details are available on the PERA website. See "Disclosure of Compensation."
- Vendor forms. Grantees must submit a City of Boulder vendor form and current IRS W-9 form in order to receive the grant award. The W-9 must be in the same name as the Grantee named on the grant application. Individual Grantees must also submit a Determination of Independent Contractor / Employee Status for Payment document and copy of their Driver's License. Applicants will receive the appropriate forms from payments@bouldercolorado.gov. Failure to supply a proper W-9 may invalidate the grant award.
- **IRS taxation.** Grant awards are non-transferable, taxable and are reported to the federal government.
- Agreement. When a grant award is made by the Boulder Arts Commission, the successful Applicant will be contacted by staff to sign a Grant Letter of Agreement. In that agreement, the Grantee will indicate the completion date of the project and the date a grant report will be submitted.
- Issuance of funding checks. Once the agreement is signed, staff of the Office of Arts and Culture will submit it to City Finance along with the invoice. Funds/checks are delivered within the next three weeks. Grants are initially funded at 80 percent of the grant amount awarded. The remaining 20 percent of the grant awarded is paid out upon receipt and Boulder Arts Commission approval of the grant report. Failure to submit a final grant report will result in ineligibility to apply for future grants.
- Acknowledgment of Boulder Arts Commission funding. All publicity for Boulder Arts Commission-funded projects must include the following credit line: *This project is funded (or funded in part) by a grant from*

the Boulder Arts Commission, an agency of the Boulder City Council. In lieu of the credit line, the Boulder Arts Commission Logo may be used. The Grantee must sign a release form and submit photographs and/or videos of the project that the Office and Arts and Culture may use on its website, social media, printed materials or for any other publicity purpose.

• Thanking City Council. It is suggested that all grant recipients write the Boulder City Council members to thank them for supporting the Boulder Arts Commission and the Office of Arts and Culture. Please let them know how this grant will be used, and the difference it will make to your organization. Please also invite them to attend your events and programs. Project summary*

Making a Mountain is a community performative installation to happen at the McMahon Gallery in the Dairy Arts Center in the Summer of this year. It involves two weeks of work with the community, sewing and sharing stories while building a large-scale installation. At the beginning, the exhibit will be an almost empty space—apart from some art pieces on the walls to give context to the exhibit—with few tables and chairs arranged in a circle. As the days pass, the joyful work, done together, will become a mound, then a mountain. During this time the gallery will be open to participants to come sew in the circle.

In a previous public art installation, I had the help of many in sewing individual tulle elements. It was watching the individual elements pile up and listening to how people shared stories and connected that I first imagined Making a Mountain. With this installation, I want to pay homage to the crafting circles of women I remember from my childhood in Buenos Aires, and many others I have encountered afterwards.

My aim is to share with visitors what happens when we come together in a nonhierarchical way—that they would contemplate hope with the experience that a random group of people can listen to each other.

All these organizations, and myself, plan on advertising sign-ups through our various mailing lists.

This close-to-my-heart project engages the community with an open invitation to all to be part of it. Participants are invited to leave their individualities and be transformed into a community of makers with a common goal in mind: making a mountain of tulle. Lately while exhibiting my work in Denver and Houston and in conversations with people around the world, mentioning this project sparks enthusiasm to travel to participate. While some may come from outside Boulder, most will be from within, and for those who come from elsewhere, they'll experience Boulder as a vibrant cultural destination. In the future, I plan to show this installation at other places (even outside Colorado); it can stand as a beacon for how Boulder supported its first creation and nurtures its own communities.

While all are welcome, I will extend specific invitations to women within two organizations representing underserved populations in Boulder: El Centro Amistad and Las Mamás Leonas. The Latin-American culture puts a strong value in coming together for the common goal of helping each other. Through this collaboration, there is a unique opportunity for the Boulder Arts Commission to support the creation of a space where participants and audiences can be enriched by each other's cultures and backgrounds.

Making a Mountain invites a civic dialogue of practice not only during the two weeks when participants will come for the communal sewing but also afterwards as the process can be watched again by visitors through a recorded video at the exhibition. I hope the installation creates conversations about the time and labor that might be invisible but embedded into the individual elements, and how the accumulation of each individual part—tulle pieces, stories, and experiences—enhances the whole.

Cultural offerings*

In what way does your project fill a gap in the variety of cultural offerings in Boulder? What is exciting or new about your project?

Making a Mountain is unlike any installation that I've seen: a community-based performative sewing circle working to grow the installation day by day. It will be a community installation dynamically performed by individuals who are called to it.

I find inspiration in my childhood in Buenos Aires, where I watched the women of my family sew together, crochet, and embroider, sharing the everyday with one another. These spontaneous circles of women gathering with a common purpose always held something intriguing for me, a power that was difficult to define but impossible to ignore. The communities they build have no use for the ego of an individual, making way for the well-being of the whole as the focus.

A community working together becomes stronger. It invites sharing, understanding, empathy, and support of each other. The handwork itself brings forward a joyful meditating presence. The growth of the sculptural tulle piece, from a mound to a mountain, is a tale of perseverance and an homage to the invisible labor that goes into such crafted works. This will be multiplied by the collaboration with El Centro de Amistad and Las Mamás Leonas as so much of Latin American culture is about coming together and creating as a community.

With this Boulder Community Grant, I am asking for funds to equitably and fairly compensate the women of El Centro de Amistad and Las Mamás Leonas, many of them undocumented and mostly mothers, for their time, labor, and commitment, and for the extra work from assistants that'll be needed to make the project happen.

While I have extended an open invitation to other Boulder communities and residents nearby to help, I choose to seek funds to specifically compensate the two communities mentioned not only for their cultural heritage of collaborations but also to recognize how their financial opportunities are limited as they navigate systems purposefully designed to be difficult.

Having the Dairy Arts Center as the location for this performative installation also serves to increase geographical accessibility to all in the community. The building is also ADA accessible, and even if someone is unable to participate in the process of sewing, they can still engage in the project through stories or simply observing. The process of making the individual elements will also be simplified and prepared to make it welcoming to more people of various sewing skill levels. Everyone is welcome to come and join in this creative process.

Proposed outcomes and evaluation strategy*

One concrete way to evaluate the success of this project will be through data collected during the two weeks of community sewing. Drew Austin, from the Dairy Arts Center, will maintain a record of participants who sew each day and the growth of the project through time-lapsed video recording for visitors to watch as the installation stays up through September. Additionally, the mountain itself will serve as a piece of data through its size and presence in the gallery. The more people that participate and hours spent sewing, the bigger the installation.

We'll ask for feedback on notes that all will be encouraged to leave. I hope one outcome will be the strengthening of the Boulder community through the connections, relationships, and support that the participants receive and share. My collaboration with El Centro de Amistad and Las Mamás Leonas is an act of mutual respect that I want participants and visitors to be inspired by. Most importantly, I want everyone to realize they are a part of the installation—that without their input, the piece would not have happened.

Leaving the possibility of surprises that often arise when involving the community, this project may spark a future project, mimicking how this one came to fruition.

In these supplementary materials, I would like to include some reference photos of prior work that I mention within the application that inspired the community performative installation *Making a Mountain*.

Flare, 2019

A billboard completely filled with tulle on both sides, high on the intersections of Glenarm PI and 20th Ave in Denver. The temporary installation *Flare* (last two photos in this section) was a first gesture to bring five Denver neighborhoods, sometimes at odds with each other, together for dialogue.

The first photo is of the sewn tulle elements of my public installation *Flare* from 2019. These are the pieces that were sewn by volunteers in my studio (photos also below), and prior to installing into *Flare*, they were gathered into mounds, one shown on the photo that I felt particularly moved by.

These other three photos are from my studio when there were roughly 16 people helping to sew the tulle elements for the installation. Some of these participants were from El Centro de Amistad, but the majority were from the Front Range Contemporary Quilters. Although they were not working in a circle, I drew notice to how they talked and shared stories while working.

With *Making a Mountain*, I want to explicitly explore this concept of coming together and watching an installation grow in relation to the shared labor and experiences.

I choose to include these next images because they show my existing relationship with El Centro de Amistad as well as an example of such crafting community circles that I refer to in my application.
