GRANT AWARDS

- Notifications and dispersal of funds. Since 2017, Boulder Symphony & Music Academy (BS&MA) has committed to accessibility in the classical music sphere. We have begun accomplishing this with one of our community outreach programs, the GLOW Project. The GLOW Project provides a stimulating, accommodating, and inclusive environment for underserved neurodiverse populations, including those living with dementia and individuals on the autism spectrum, to experience music.

BS&MA is launching an eight-week class series for people living in the early stages of dementia. Throughout the series, individuals will meet on a weekly basis for hour-long classes to continue developing cognitive and fine motor skills through music-making, which is scientifically proven to delay some dementia symptoms and enrich one's quality of life.

BS&MA is also hosting a GLOW concert played by our entire orchestra. This interactive concert features Igor Stravinsky's The Rite of Spring, an exciting and poignant work recognized by many, making it ideal for neurodiverse audiences.

Both the class series and GLOW concert are led by a board-certified Music Therapist and community partners to provide opportunities for social interaction, as well as cognitive and sensory stimulation.

Boulder Symphony & Music Academy's GLOW Project supports artists and creative professionals by offering unique programming experiences that allow them to work intergenerationally with underserved populations and play in non-traditional concert programs. Our focus on neurodiverse individuals furthers our reach to include not only artists and creatives, but also to the cultural organizations that serve these individuals, their care partners, and their families.

The GLOW Project increases civic dialogue about how culture can positively affect the community by hosting outreach projects for various underserved populations. These ideas have been replicated by other organizations in the community and conversations with members of the community have increased awareness of the need for these programs.

The GLOW Project has a focus on creativity in the public realm by providing experiences for populations that don't typically attend symphony concerts or take music classes. These concerts allow interaction and movement among the attendees, and our group class offers opportunities for creative expression and cognitive stimulation.

The Boulder Symphony & Music Academy's GLOW Project amplifies Boulder's cultural destinations by providing programming that has never been done. By increasing our program offerings, we simultaneously increase diversity among the populations that feel welcome at such cultural destinations.

Cultural offerings*

In what way does your project fill a gap in the variety of cultural offerings in Boulder? What is exciting or new about your project?

People that our GLOW concerts serve are made to feel unwelcome at classical music concerts through norms that value quiet, non-participatory audiences. GLOW concerts welcome all people, regardless of ability, into an accommodating space where they can be themselves. Resultantly, GLOW concerts add variety to cultural offerings by creating opportunities for individuals in underserved communities to experience classical music in environments that prioritize participation and comfort.

Our eight-week class series specifically targets folks in the early stages of dementia. These individuals often find themselves living independently but not partaking in the everyday activities prior to their diagnosis. People in advanced stages of dementia typically live in an assisted living facility, receive intensive care from medical professionals, and can access life-enhancing activities provided by the facility. However, people in the early stages of dementia, especially BIPOC folks, lack the resources and opportunities of such an environment and are left to seek out life-enriching activities on their own. Our class series aims to fill this gap in current cultural programming.

Boulder Symphony & Music Academy created the GLOW Project to reach underserved and underrepresented communities who are not able to attend our subscription concerts. We design an accommodating environment, offer tickets free of charge, and develop unique programming specific to those individuals. As such, the GLOW Project is a prime example of cultural equity.

As people of color are disproportionately affected by dementia and other neurodiverse conditions and by and large have less access to the arts than white-bodied folks, we are prioritizing the intersection of race and ability through our GLOW concert and class series. We are partnering with the Alzheimer's Association to intentionally further our reach into these marginalized communities.

Boulder Symphony & Music Academy is committed to racial equity through diversifying our board members, offering 22 full-tuition scholarships at our music academy for BIPOC students, hiring bilingual instructors, and partnering with local organizations such as Boulder MUSE to offer complimentary concert tickets to low-income families. We recognize the importance of reflecting the community one serves so as to engage with it authentically, and we are actively pursuing this goal.

Proposed outcomes and evaluation strategy*

The goal of the GLOW Project is to create opportunities for underserved populations. We increase potential for social interaction and cognitive stimulation through familiar music in dementia-friendly concerts. We increase possibilities for tactile and sensory stimulation and social awareness in sensory-friendly concerts. In the first years of GLOW concerts, audiences listened to string quartets. We have since grown into offering full orchestra concerts, clearly demonstrating the growth and potential for such events. A main evaluation strategy for the class series will be through a participant survey completed before and after the series. Our board-certified Music Therapist partner will provide additional evaluation support.

A long-term goal of the GLOW Project is to help provide regular musical opportunities for the community. After starting the GLOW Project in 2017, other symphonic groups in Colorado have begun similar programming. By offering a music class series for adults with developmental and intellectual disabilities, we are creating the potential for this idea to spread to other organizations. This, in turn, continues increasing opportunities for both musicians and this profoundly underserved population in Boulder.
