Meeting Summary

Questionnaire Summary: The Institute for the Built Environment provided a summary of the governance and structure questionnaire completed by the Advisory Panel. The questionnaire showed a desire to move General Business Meetings to every other month for 1.5 hours and host 1-2 hybrid inperson/online general business meetings in 2025. The panel expressed a desire to increase the frequency of topical meetings and the frequency of working group meetings, keeping general business meetings and webinars open for public observation and working group meetings open to the public on a case-by-case basis. Additionally, the panel expressed interest in being in more of a consultant role, helping to identify solutions and engage in problem solving, rather than primarily being given updates on partnership activities.

The panel expressed interest in filling the three vacant seats on the panel, utilizing the same process as was originally used to recruit and select the current panel. Recommended representation included business, technical experts, equity, and institutional representatives (e.g., BVSD or EPA).

The Advisory Panel members voted to prioritize their interests for future focus groups, resulting in the following distribution of involvement across various topics. Each member was offered three votes.

- Microgrids & Virtual Power Plants (VPPs): 8 votes
- Building Electrification Pilot Oversight: 4 votes
- Increasing Heat Pump Adoption: 4 votes

- Resiliency & Reliability (Beyond VPPs & MGs): 3 votes
- Integrating Partnership with BVSD Efforts: 2 votes
- Small Nuclear Reactors: 1 vote
- Partnership Agreement Evaluation & Recommendations: 1 vote

Additional working groups and webinars for 2025 will be scheduled accordingly.

Just Transition Solicitation: Xcel presented an overview the Just Transition Solicitation (JTS) application to the Public Utilities Commission. The JTS is resource plan for new electricity generation resources that will be needed in the coming years to replace retiring coal plants and meeting growth in electricity demand. Key aspects of the plan include reducing 80% of emissions by 2030, maintaining reliability, meeting load growth needs, addressing complexities, and seizing opportunities. Xcel is exploring 6 key areas within the Just Transition Plan. The Advisory Panel was given an opportunity to ask questions regarding the plan.

Virtual Power Plant (VPP) Grant Award: Xcel provided an update on the VPP grant, which is a partnership with the National Renewable Energy Laboratory (NREL), Boulder and the University of Colorado. The project was selected for a \$12.7 million award by the Department of Energy (DOE). The focus areas for this energy partnership include energy efficiency, building electrification, transportation electrification, local renewables, innovative programs, and grid reliability & resiliency. NREL also shared an overview of its contributions to the technical aspects of the project.

City of Boulder Updates: The City of Boulder provided an update on the City Council's adoption of the Climate Action Plan as a key priority for the city and an update on the Healthy Buildings, Stronger Community program, which aligns with the city's broader climate goals.

Heat Pump Accelerator Pilot Update: Boulder has completed outreach and focus group efforts to the public for the pilot program. Boulder will be presenting a summary of the findings from this outreach to the panel in an upcoming webinar.

Local Generation 2.0: Boulder is planning to update its local generation target to move from just a MW of generation capacity target to one that more broadly incorporates energy storage and resilience. Boulder has also been conducting outreach efforts to better understand the community's needs and perceptions around resiliency. In Q1 of 2025, Boulder will establish a working group to engage with the community on resiliency strategies and gather more input.

Dashboard Update: Xcel provided an update on their progress of the dashboard creation. Xcel noted that because of current technology limitations, they are currently focusing on a newsletter format rather than web-based dashboard. Xcel will seek feedback from the Panel once they have a preliminary template ready to share.
