Historic District Designation Information

Thank you for your interest in creating or amending a local historic district. Please read each of the following statements. If you support the submittal of a historic district application, provide your name, signature, address and date in the "Acknowledgement" section below.

- 1. I understand my property is proposed to be included in a local historic district in the City of Boulder.
- 2. I understand that in order to submit the Historic District Designation application, owners of at least 25 percent of properties are required to sign this petition.
- 3. I understand after an application is submitted, the Boulder Revised Code (B.R.C.) requires a series of public hearings to be held. Once submitted, the application cannot be withdrawn.
- 4. I understand the designation process is outlined in Title 9, Chapter 11, B.R.C. 1981 and includes:
 - A public hearing at a Landmarks Board meeting, in which the board decides whether or not to accept the application (Initiation Hearing; held within 45 days of a complete application); This hearing is not required if the application is submitted by all property owners, Landmarks Board or City Council.
 - A meeting with all owners;
 - Development of design guidelines, if applicable;
 - A public hearing at a Landmarks Board meeting, in which the board makes a recommendation to Council (Designation Hearing; held within 60-120 days of the Initiation Hearing);
 - Review by the Planning Board, in which the board makes a recommendation to Council;
 - If recommended by Landmarks Board, a consent agenda item at City Council, for the 1st Reading of the ordinance.
 - If recommended by Landmarks Board, a public hearing at City Council, for the 2nd Reading of the ordinance. Council may approve, modify and approve, or deny the application.
- 5. I understand that before the Landmarks Board Designation Hearing, a formal questionnaire will be mailed to each property owner asking whether they support, oppose, or have no opinion on the proposed designation.
- 6. I understand my opportunities to provide public comment include:

- Speaking at the public hearings at the Landmarks Board and/or City Council meetings;
- Writing letters or emails to the Landmarks Board, Planning Board and City Council;
- 7. If designated, I understand all exterior changes to properties within the district require review through a Landmark Alteration Certificate to ensure the changes are compatible with the district's historic character.
- 8. If designated, I understand I may be eligible for benefits, including Preservation Tax Credits and modifications in the Building Code, Energy Code, Zoning and Flood Requirements.
