1986: Floodplain mapping study.

1996: The University of Colorado commissioned a flood study as part of its due-diligence review to purchase the 315-acre site which is now called the CU-Boulder South Campus. During this evaluation, inaccuracies in the 1986 regulatory flood mapping were discovered. This study identified significant flood spills over US 36 that would impact east Boulder areas in what has subsequently been called the "West Valley Overflow" area. Studies commissioned by the city and the Urban Drainage and Flood Control District (UDFCD) revised the 100-year floodplain mapping.

April 17, 2007: City Council approved a motion authorizing the submittal of the flood study to FEMA.

WRAB motioned to move forward with four of the nine alternatives (a pipe alternative was eliminated) including:

- 1. Maintaining the status quo;
- 2. High hazard and critical facility protection;
- 3. Regional detention at US36 with downstream improvements; and
- 4. Distributed regional detention.

Four sub-alternatives were developed for the regional detention at US36 facility:

- 1. A wall centered on the US36 median barrier;
- 2. A detention facility located on some of the current US36 expansion project right-of-way;
- 3. A detention facility located outside of the current US36 expansion project; and
- 4. A detention facility located outside of the ultimate configuration of the future US36 corridor.
