Prior to Submittal

Prior to submitting an application for electronic submittal, review the Administrative Review (ADR), Board of Zoning Adjustment (BOZA), Historic Preservation, Land Use Review (LUR), Technical Document Review (TEC) and Revocable application(s) and applicable attachment(s) for the review requirements that most closely match your proposed project. You can find applications and attachments in our <u>Applications and Forms Database</u>. Once you have gathered all application requirements (as listed either in the review application or its respective attachment) proceed through the process outlined below.

How To Submit an Initial Application

Provide a completed application form, written statement (as requested on the application form or review attachment) and a site plan *only* to PDSskipatrip@bouldercolorado.gov. If you do not have a site plan (because there is no exterior scope of work), provide a proposed floor plan *only*. The project specialist team will review applications on a first come-first served basis. Application forms and site plans will be reviewed for proposed project details and scope. Additional information may be requested. If additional information is not required, a project specialist will create an EnerGov case and contact you through the system with next steps, including uploading digital files through the "Attachments" tab in the CSS portal. We will also invoice the application fee at that time (if applicable). A complete application package and payment of the application fee will be required prior to routing the application for review. Files must be formatted as specified below to be accepted for review.

How to Resubmit a Development Review/ Plan Case

Resubmittals should have the following components:

FULL set of electronic drawings including pages that did not change and revised
documentation/ drawings addressing the review comments. Revised plans must include
clouding of all changes and the date of ALL revisions. These must be saved as PDFs. See
requirements below.

Resubmittal materials shall be uploaded through the "Attachments" tab in the CSS portal using the naming conventions below. Some projects may have multiple plans being reviewed concurrently (e.g. site review, use review, parking reduction, etc.). Related plans should be resubmitted at the same time. Failure to resubmit for related plans at the same time will delay the review process. If any new applications are required based on submittal comments, those should be submitted following the Initial Application instructions above.

Preparing a Digital Submittal

Read the following instructions carefully. Improperly formatted plans will delay the plan review process for your project.

ALL PDFs / FILES MUST BE SUBMITTED AT THE SAME TIME THROUGH THE CSS PORTAL.

ONCE YOU CLICK SUBMIT, YOU WILL NOT BE ABLE TO UPLOAD ADDITIONAL DOCUMENTS

UNTIL A PROJECT SPECIALIST HAS REVIEWED YOUR SUBMITTAL.

All plans must be saved as PDF files. No PDFa-s, JPEGs, PNGs, Word Documents, etc.
can be accepted.
Combine plans into one PDF if they were prepared by the same individual.
Otherwise, submit separate files for each discipline in order to preserve digital
signatures. See file naming conventions below.
Reports and other documents must be submitted as separate PDFs (e.g. forms,
worksheets, calculations, specifications, reports, etc.). See file naming conventions
below.
No zipped files or PDF packages can be accepted.
Files must be unlocked/ unprotected.
Fast Web view must be enabled on all PDFs (this can be done using free online
tools).
PDFs must be saved as reduced file size (this can be done using free online tools).
File sizes cannot exceed 100 MB.
Maximum drawing size shall be no greater than 24" x 36".
All sheets shall be oriented so that the top of the sheet corresponds with the top of
the computer monitor.

Drawings must be legible, scalable (to a standard architectural or engineering scale)
and include a graphic scale bar on every page.
Each plan sheet must include the project name and address.
Each plan sheet must be marked to clearly identify the content of the page
(Example: Sheet A1.0 Architectural Site Plan).
On the cover page, include a 3-inch by 3-inch space in the lower-right corner
reserved for the city's approval stamp. This may be offset the <u>minimum</u> needed to avoid
conflict with preferred title block.
Electronic stamps for corresponding design professionals shall be included on each
applicable plan page or report cover. Refer to the Colorado Department of
Regulatory Agencies requirements for electronic stamps and signatures.
